The site is located in the sought after village of Wrea Green, approximately 4 miles north east of Lytham in Lancashire.

The site is a 5 minute walk (0.3 miles) from Wrea Creen village centre.

Wrea Geen has been the winner of the best kept village several times, and provides an attractive village church, green with duckpond, a 19th century pub and tennis club alongside other amenities. In addition, the village primary school has an outstanding OFSTED rating, with excellent secondary schools in the locality including the private Kirkham Grammar School. The neighbouring small towns of Lytham and Kirkham also host a number of top-performing high schools and independent Grammar schools.

Locally to the development there are a wide range of bars, restaurants and cafés, including the award winning Ribby Hall Village, The Orangery at The Spa Hotel, Orathai Restaurant and The Villa. Close by is also Lytham Green Drive Golf Club and St Anne's Old Links Golf Club.








THE BADMINTON 4 bed, detatched house


